The Regime in Jordan Allows the Jew who Killed Two Sons of the Country to Leave Jordan; turning a blind eye to the Dignity of its People

Once again, the regime in Jordan affirms its intimate relationship with the Jewish entity of the usurping aggressor of the Land of Al-Israa and Al-Maraj, and reiterates its commitment to perpetuating and strengthening this shameful sinful relationship regardless of the crimes committed by the Jewish entity against the people of Jordan, the people of Palestine and the blessed Al-Aqsa Mosque.

The media reported the news of the reception of the Prime Minister of the Jewish entity for the criminal who killed two sons of the country in cold blood in the Jordanian capital, which was defiled by the unIslamic presence of the embassy of the Jewish entity on it, the result of the treaty of humiliation and shame, (Wadi Araba) signed by the Jordanian regime with the Jewish entity, betraying the Muslim Ummah while it was not aware.

Once again, the regime in Jordan tries to dress the people of Jordan with the cloak of shame and humiliation. After being indifferent to the blood of the Jordanian judge Ra'id Zu'aitar and the blood of the son Al-Karak, the son of the Al-'Amr clan and the policeman, the son of Al-Jarrah clan, it is abandoning the blood of Al-Dawaimah's son and Al-Hamarneh's son and allowing the Jewish criminal to leave the country. The Minister of Interior Ghaleb Al-Zu'bi in an attempt to justify this shame said infront of the Jordanian House of Representatives that the son of Al-Dawaimah is the one who initiated the assault on the Jewish criminal, who was received by Netanyahu with a heroes' reception. This is a slap on the face to the people of Jordan and humiliating their dignity, but it is a slap by the hands of the Jordanian regime whose prime duty is to preserve and maintain the dignity of the country and its people.

If the murderer from the people was from the military and carried out his duty towards the occupiers or the aggressors, they will say he had violated the military orders, as happened with the soldier Ahmed Ad-Daqamsha and Sergeant first battles, Abu Tayeh. What injustice, humiliation and shame that this regime wants for us in this country and we are the descendants of Khalid Ibn Al-Walid and Abu Ubaida and Sharhabil Ibn Hassana and Salah Ad-Din and Az-Zaher Baybars and Qutuz?! What injustice, humiliation and shame this regime wants for us and we are the sons and grandsons of the heroes of the Battle of Al-Karama?! Considering the return of the Jewish criminal to the Jewish entity and letting him escape from our grip as a deal with the Jewish entity to remove the electronic gates from the entrances of Al-Aqsa Mosque, is more humiliating; it is a waste of the blood rights of the country's people in exchange for the survival of Al-Aqsa Mosque under the occupation by improving the situation of the Occupation.
